Vendors CANNOT breakdown until 9:00 pm & **MUST be OFF the street by 9:50pm.or you will be charged \$120.00.** So take down & pack BEFORE getting your vehicle. Read ALL & sign pg 2. Rain or Shine – Sorry No Refunds

Please don't ruin it for the rest of us. City & State can refuse to allow this event if you are not off the street by 9:50 pm. Our event is on a Federal Hwy of which we have to request closure. We must have street opened no later than 9:50 pm. This means pack your items BEFORE getting your vehicle, just like when you arrive you unload, move your car, then set up. Our streets are narrow so please use common sense & courtesy. \$120.00 charge for any vendor not off street by 9:55 pm.

Vendors must provide own tent, tables, chairs, lighting, etc. NO electricity available so please come prepared. If you require more than 10 x 10 please indicate & pay appropriately.

We will be happy to try to accommodate those that would like to request a location for an Additional \$50.00. Understand that this does not guarantee that location as many factors are involved with placement. No refunds if we are unable to accommodate.

WAIVER: The Downtown Titusville Merchants Association reserves the right to refuse any vendor application, should this occur the fee will be refunded. The Vendor shall defend, save and hold harmless the Downtown Merchant Association, their respective officers, agents, board members, staff, volunteers, sponsors and assigns from any claims, damages, losses, liability or expense which may arise, and shall not be held responsible for any loss or damage due to fire, accident, theft, weather, acts of God, vandalism or any other loss or injury whatsoever or not specifically described herein, whether past, present or future. Booths are not insured by the Downtown Titusville Merchant Association or any sponsoring agents. Exhibitors must make provisions for safeguarding their goods. I acknowledge that I have read all of the information, rules and regulations and agree to be bound by this contract. I understand there are no refunds even if I am late & denied entry, falsify information, asked to leave or cancelation due to weather.

ALL VENDOR VEHICLES MUST BE IMMEDIATELY OUT OF EVENT AREA –drop off only. NO cars will be allowed in, even for drop off after 5:00. NO Exceptions! You are allowed to drive back in at approx. 9:05 pm-pack & tear down before getting your vehicle & depart OFF STREET by 9:50pm. NO Refunds. Rain or Shine
