We've moved the festival to a larger site in the Titusville Commons Parking area just east of US 1 in downtown Titusville.

Set up begins at 3 pm Friday and vendor parking is nearby in the City Hall lot. There is no security overnight but you can leave your tent up at your own discretion. We are NOT responsible for any loss, theft or damage.

The festival draws 3000+ visitors over the two days. There are many activities: educational booths, a scavenger hunt, children's art show, live music and food trucks. All the fun happens in one compact area so you can be sure that, even though there is a lot to do, families will be looking at your booth.

Sign up is through the Downtown Titusville Merchants Association (DTMA). If you have already paid them to attend the June Friday Nite Live you can add Saturday for an additional \$40.

Late charge of \$25.00 due if not in by 4:00. All other Vendors must be set up not later than 4:45 pm.

I acknowledge that I have read all of the information, rules and regulations and agree to be bound by this contract. I understand there are no refunds even if I am late & denied entry, falsify information, asked to leave or cancellation due to weather.

ALL VENDOR VEHICLES MUST BE IMMEDIATELY OUT OF EVENT AREA –drop off only. NO cars will be allowed in, even for drop off after 4pm Fri/8am Sat. NO Exceptions! You are allowed to drive back in at approx. 9:10pm Fri/4:10pm Sat to load & depart by 10:00pm Fri/5:30pm Sat.
