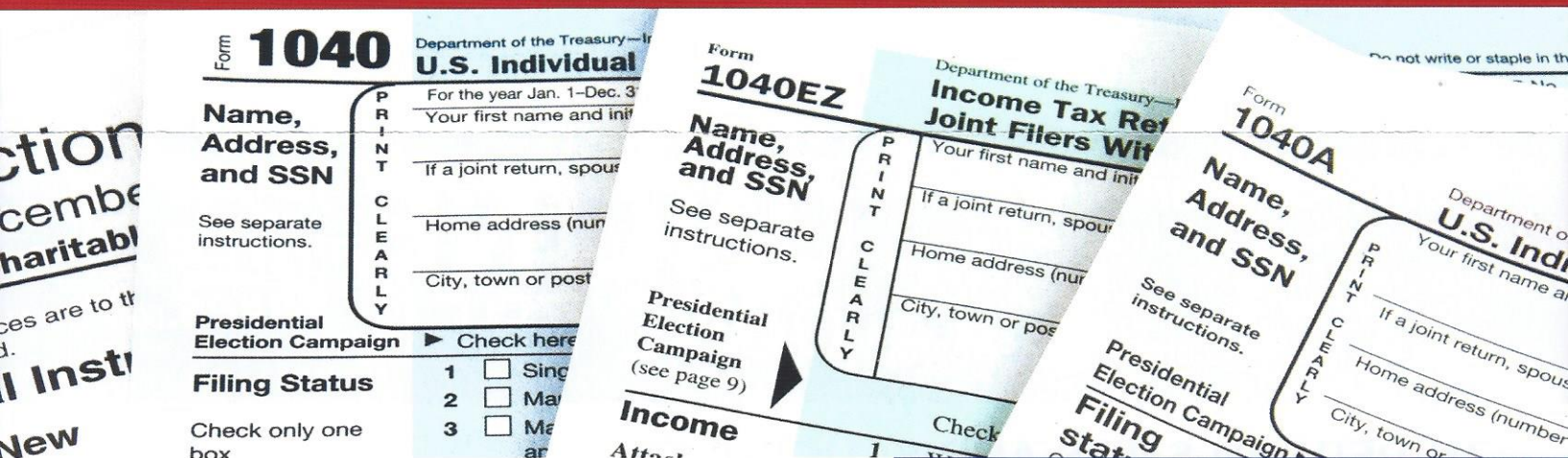

# REQUIREMENTS

Adjusted gross income less than:

	Single	Married
with no qualifying child	\$14,880	\$20,430
with one qualifying child	\$39,296	\$44,846
with two qualifying children	\$44,648	\$50,198
3 or more qualifying children	\$47,955	\$53,505

Are you eligible for EITC? You must have:

- Earned income
- A valid Social Security number
- Less than \$3,400 in investment income
- Joint tax-filing status, if married
- U.S. citizenship or resident alien status for past year (*in most cases*)
- Between ages 25 and 65 years old in 2016

Be sure to bring these items with you:

- Last year's tax return (if available)
- Social Security cards or taxpayer identification number (all family members)
- A photo ID (both you and your spouse if filing jointly) **Joint returns require both filers to be present to sign**
- Wage and earning statement(s) Form: W-2, W-2G, 1099-R, 1099-Misc
- Interest and dividend statements (Forms 1099)
- Name, address and SSN/EIN of child care provider/amount paid
- 1098-T, Tuition Statement
- Proof of bank account numbers for Direct Deposit, such as a blank check
- 1095, Health Insurance Statement
